Mayor and Board Members,

As part of the Southside Water Improvement Project (SWIP) we have been working with United Consultants to acquire easements for the installation of a 12 inch water main to complete the south side loop of the water system. After review with Board of Works, City Attorney, City Engineer, Donohue, and United Consultants, we found it desirous to revise the title searches an additional 10 years for the 10 of the 12 easements not yet presented to the Board for acceptance. The remaining 6 outstanding easements that have not had offers accepted yet will have the same 30 year search included. United Consultants will be providing an additional 3 parcels with easement descriptions that were going to be right of way acquisition that is now unnecessary.

# UPDATE OF TITLE SEARCHES AND TITLE & ENCUMBARENCE (T&E) REPORTS

The Southside Water Improvements Project requires the acquisition of easements along Morristown Pike, north of Davis Road. The Owner has requested that the ten (10) parcels not yet presented to the Board of Works have the title searches extended from the originally requested 20 years to 30 years. This work will also involve updates to the T&E Reports.
