An accepted contractors bid must be submitted to INDOT within 4 months (**Friday 6/27/2025**) from the date of the CCMG award date. **Failure to do so will result in your grant funding being forfeited.**

A general scope/description of the Project is as follows:

1.5" milling and 2" HMA overlay plus ancillary work for 31 segments of local city roads totaling 36,517 linear feet of roadway (111,576.22 square yards).

The maximum amount of state funds allocated to the Project is **\$1,026,516.05**
