

ORDINANCE NO. 2024/28

AN ORDINANCE AMENDING TITLE VII, CHAPTER 74, SCHEDULE III OF THE CODE OF ORDINANCES OF THE CITY OF GREENFIELD, INDIANA

WHEREAS, it has been recommended to the Common Council of the City of Greenfield, Indiana, by the Greenfield Traffic Safety Committee, to amend Title VII, Chapter 74, Schedule III pertaining to a reduction in the speed limit for all traffic traveling on Morristown Pike between Main Street (US Highway 40) to a point 2,300 feet South of Davis Road (County Road 100 South); and

WHEREAS, the Common Council of the City of Greenfield, Indiana, believes that the amendments recommended by the Greenfield Traffic Safety Committee are in the best interest of the health, welfare, and safety of the citizens of Greenfield, Indiana.

THEREFORE, BE IT ORDAINED by the Common Council of the City of Greenfield, Indiana that:

SECTION I

Title VII, Chapter 74, Schedule III, of the Code of Ordinances of the City of Greenfield, Indiana, should be amended by deleting the following:
