The Greenfield, Indiana Common Council met in regular session on the 11th of December, 2024 at 3:00 p.m. in the Council Chambers, Room 127 located at 10 South State Street with Mayor Guy Titus presiding. The Invocation was given by Councilman Dan Riley followed by the Pledge of Allegiance led by Councilman John Jester.

## **MISCELLANEOUS BUSINESS:**

Swearing in of Officer John Kim by Police Chief Brian Hartman and Mayor Titus.

This item took place at the beginning of the meeting.

Clerk-Treasurer Lori Elmore confirmed the annual requirement of the members of the Council, Mayor and Clerk-Treasurer completing their nepotism and contract purchasing declarations had been completed at the start of the meeting.

<u>Clerk-Treasurer Lori Elmore</u> confirmed to the members of the Council that both the Civil City and the Fire Territory had been successful in their three year excess levy appeal which had been submitted to the DLGF earlier in the year.

Civil City - The DLGF confirmed they have approved an increase to the Civil City's max levy beginning in the fiscal year of 2025, for the amount of \$688,249.00 This is a one-time payment and will increase the annual max levy amount over the next ten years, generating an additional \$6,882,490.00 in revenue.

Fire Territory - The DLGF confirmed they have approved an increase to the Fire Territory's max levy beginning in the fiscal year of 2025, for the amount of \$506,733.00. This is a one-time payment and will increase the annual max levy amount over the next ten years, generating an additional \$5,067,330.00 in revenue.

Clerk-Treasurer Lori Elmore confirmed to the members of the Council that the 1782 Notice had not been received but was expected by year end.

Mayor and members of the Council - Year End Wrap Up and Final thoughts on the year 2024 with best wishes for 2025!

Mayor Titus expressed his thanks to everyone who had helped to make his first year as Mayor such a success. He highlighted a few of the things which stood out to him and stated he was looking forward to next year.

Council President Dan Riley also thanked everyone for their work this past year and informed the members of the Council that he would not be seeking re-election as the Council President in 2025. He has served as Council President for many years and wanted to share the responsibilities with other members so they could learn and enjoy the role. He thanked the members of the Council for having been elected to serve as Council President.

Councilman Jeff Lowder thanked Councilman Riley for the many years he had led the Council expressing his gratitude for the leadership he had given to the years he served as Council President.

Mayor Titus thanked everyone once again and then led the Annual Year End Toast with all those present, bidding them his very best wishes in 2025!! Cheers!
