ORDINANCE NO. 2025/07

AN ORDINANCE VACATING PUBLIC EASEMENTS WITHIN THE CITY OF GREENFIELD, INDIANA

WHEREAS, the City of Greenfield, Indiana is the owner of certain easements described and depicted on Exhibit A and on Exhibit B, attached hereto and incorporated by reference herein; and

WHEREAS, as partial consideration for the grant of a Perpetual Exclusive Utility Easement from Karen L. Bullington to the City of Greenfield, Indiana in conjunction with the Waterview Lift Station Project, said easement covering an area of 0.118 acres more or less and which is described and depicted on Exhibit C, attached hereto and incorporated by reference herein, the easements described on Exhibit A and Exhibit B are no longer needed and provide Karen L. Bullington with a usable building area on Lot 153 of the Waterview Subdivision; and

WHEREAS, after appropriate notice was published within the Greenfield Daily Reporter and posted at the Keith McClarnon Government Center, a public hearing was held regarding the adoption of said ordinance on the 26th day of March 2025, where all interested persons were given an opportunity to speak as to the vacation of said public easement; and

WHEREAS, the Common Council of the City of Greenfield, Indiana believes the vacation of said public easements to be in the best interest of the health, safety, and welfare of the citizens of Greenfield, Indiana, as well as the efficient management of the Greenfield Water Utility.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:

SECTION I

The real estate described on Exhibit A and depicted on Exhibit B, attached hereto and incorporated by reference herein, is hereby vacated with the ownership thereof going to the adjoining property owner.

SECTION II

The Clerk-Treasurer shall furnish a copy of this ordinance to the Hancock County Assessor, Hancock County Auditor, and Hancock County Recorder.

SECTION III

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
