SHORT TERM RENTAL AGREEMENT

Comes now the City of Greenfield, Indiana, hereinafter referred to as "Greenfield" and Greenfield Main Street, Inc., hereinafter referred to as "Main Street" and do hereby enter into this lease and agreement for the premises described as follows:

That portion of South Street within Greenfield, Indiana existing between State Road 9 and American Legion Place encompassing all of the bricked and concrete areas contained therein.

For the term of December 6, 7, 8, 13, 14, 15, 20, 21, 22, 23, 26, 27, 28, 29, 30, 31, 2024 and January 1, 2025 on the terms and conditions set forth below.

In consideration thereof, Main Street covenants and agrees:

- 1. To pay to Greenfield as rent for the premises the sum of One Dollar (\$1.00) for the entire term of this Agreement in lawful money of the United States of America, which payment shall be due and owing upon execution of this Agreement by all parties.
- 2. Main Street will use and occupy said premises for the purpose of offering to the public the ability to ice skate upon an area prepared for such purpose by Main Street. The hours of operation of the skating facility are as follows:
- a. December 6, 13, and 20, 2024 between the hours of 4:00 p.m. and 10:00 p.m. Eastern Standard Time.
- b. On all other dates encompassed by this Agreement, the hours of operation shall be from 11:30 a.m. to 10:00 p.m. Eastern Standard Time.
- 3. Main Street, at its own expense, will install all necessary materials to create the ice-skating rink.
- 4. Main Street, at its own expense, will keep the leased premises in good repair, clean, sanitary, and in a safe condition for utilization by members of the public at all times during the term of this Agreement, including without limitation, the removal of ice and/or snow, provision for disposal of trash and other waste materials and the provision of staff to properly supervise utilization of the leased premises in a safe manner.
- 5. Taking possession of the leased premises by Main Street shall constitute acceptance of the premises conditions at the commencement of the lease term and at the end of the lease term, Main Street shall return the leased premises in substantially the same condition.
- 6. Main Street will not assign this lease nor any interest hereunder, nor permit any assignment by operation of law, nor permit the use of the leased premises by any third party other than the general public, without a written agreement between Main Street and said third-party incorporating by reference the terms of this Agreement.

- 7. Other than those alterations to the leased premises necessary to conduct the skating rink operation, Main Street will not make any other alterations, additions, or improvements to the leased premises without first obtaining Greenfield's written consent thereto.
- 8. Main Street will at all times during the term of this Agreement, maintain comprehensive general liability insurance with minimum limits of \$2 million per person and \$2 million per incident, all of which shall list Greenfield as an additional insured.
- 9. Prior to the commencement of the lease term, Main Street shall provide a Certificate of Insurance to Greenfield reflecting maintenance of comprehensive general liability insurance with the aforementioned limits and reflecting Greenfield as an additional insured.
- 10. Main Street shall hold harmless and indemnify Greenfield for any damage to either person or property sustained by Main Street or any third party by entry upon or utilization of the leased premises, which indemnification shall include, but not be limited to, any claims, causes of action, lawsuits, damages, judgments, court costs and attorney's fees, which may be awarded against Greenfield or incurred by Greenfield as a result of any such claim, cause of action, or lawsuit.

RENTALAGREEMENT
