ORDINANCE NO. 2025/09

AN ORDINANCE AMENDING TITLE IX, CHAPTER 90, § 90.03(H)

WHEREAS, there currently exists within the Code of Ordinances of Greenfield, Indiana under Title IX, Chapter 90, § 90.03(H) a provision making it unlawful to use any inhumane trap within the City limits; and

WHEREAS, there currently exists within the Indiana Code a provision regarding the use of inhumane traps located at I.C. 14-22-10-10 that prohibits a local unit of government from regulating in any way the trapping of wild animals, except for the trapping of wild animals on or in land, buildings, or other real property that is owned by the unit of local government; and

WHEREAS, in order to bring the Code of Ordinances of Greenfield, Indiana into compliance with I.C. 14-22-10-10, the provisions of Title IX, Chapter 90, § 90.03(H) require revision which revision the Common Council of the City of Greenfield, Indiana believes is in the best interest of the health, safety, and welfare of the citizens of Greenfield, Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:

SECTION I

Title IX, Chapter 90, § 90.03(H) shall be deleted and inserted in lieu thereof shall be the following:

It shall be unlawful to use any humane trap within the City limits to trap any domestic animal as defined herein.

SECTION II

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
