ORDINANCE 2025/06

AN ORDINANCE APPROPRIATING FUNDS IN THE LOCAL INCOME TAX FUND-PUBLIC SAFETY

WHEREAS, the City of Greenfield, in § 30.20 of the Code of Ordinances, created a Local Income Tax Fund ("LIT FUND"); and

WHEREAS, the utilization of the LIT FUND shall be for public safety purposes; and

WHEREAS, additional funds are needed for the purchase of replacement vehicles and equipment necessary to place said vehicles into service.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:

SECTION I

That for the expenses of said City of Greenfield, Indiana, the following additional sums of money are hereby appropriated from the LIT Public Safety Fund Account #2240:

Police Department Budget

Account #2240	Purchase of replacement vehicles	\$305,000.00
Account #2240	Purchase of miscellaneous equipment	\$ 93,000.00

Total amount of \$398,000.00 not to exceed the amount of \$399,000.00.

SECTION II

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
