ORDINANCE NO. 2025/08

AN ORDINANCE AMENDING ORDINANCE NO. 2021-19

WHEREAS, the Common Council of the City of Greenfield, Indiana has heretofore approved and adopted Ordinance No. 2021-19 which in part appropriated monies from what is now called the Local Income Tax-Public Safety Fund, now known as Fund #2240, in part for the purchase of a tanker truck for the Greenfield Fire Territory; and

WHEREAS, based on information from the then serving Fire Chief, Brian Lott, the sum of \$460,000.00 was appropriated for the purchase of a tanker truck; and

WHEREAS, unbeknownst to the Common Council of the City of Greenfield, Indiana, Fire Chief Brian Lott had not obtained bids for the construction and purchase of said tanker truck and when those bids were received and the unit delivered to the Greenfield Fire Territory, the actual cost of the unit was \$579,727.00; and

WHEREAS, in order to defray the expense of the tanker truck in question in full an additional appropriation of funds from the Local Income Tax-Public Safety Fund #2240 is necessary and the Common Council of the City of Greenfield, Indiana believes the additional appropriation is in the best interest of the health, safety, and welfare of the citizens of Greenfield, Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:

SECTION I

Ordinance 2021-19 shall be amended so as to show the appropriation to the Greenfield Fire Territory Budget for the tanker truck originally in the amount of \$460,000.00 shall be amended to be in the amount of \$579,727.00.

SECTION II

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
