

ORDINANCE NO. 2024/26

AN ORDINANCE TO ADOPT AN EV CHARGING PLAN FOR THE CITY OF GREENFIELD, INDIANA

WHEREAS, the Common Council of the City of Greenfield, Indiana recognizes the increased use and availability of electric vehicles; and

WHEREAS, the Common Council of the City of Greenfield, Indiana believes the promotion of the use of electric vehicles to be one of many steps to address environmental concerns of the citizens of Greenfield, the state of Indiana, and the nation; and

WHEREAS, the Greenfield Department of Planning and Engineering has previously received a grant from the Indianapolis Metropolitan Planning Organization for the purpose of developing and implementing an EV Charging Plan for the City of Greenfield, Indiana in order to further encourage utilization of electric vehicles within the City of Greenfield, Indiana; and

WHEREAS, various members of the City of Greenfield, Indiana staff and members of the public have met to discuss appropriate locations for EV charging stations with the City of Greenfield, Indiana and other related matters; and

WHEREAS, after numerous meetings and discussion, the Department of Engineering and Planning of Greenfield, Indiana has developed an EV Charging Plan for the City of Greenfield, Indiana, a summary of which is attached hereto as Exhibit A and incorporated by reference herein with the full text of the plan being available for inspection and review in the office of the Clerk-Treasurer of Greenfield, Indiana at 10 South State Street, Greenfield, Indiana, Monday through Friday from 8:00 a.m. to 4:00 p.m.; and

WHEREAS, after the creation of the EV Charging Plan for the City of Greenfield, Indiana, and after due publication, a public hearing was held regarding the contents of said plan on the 25th day of September, 2024 at which members of the public were invited to express their opinions and comments upon said plan; and

WHEREAS, after conduction of the aforementioned public hearing, the Common Council of the City of Greenfield, Indiana believes the adoption of the EV Charging Plan for the City of Greenfield, Indiana is in the best interest of the health, safety, and welfare of the citizens of Greenfield, Indiana.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:

SECTION I

The Common Council of the City of Greenfield, Indiana hereby adopts the official EV Charging Plan for the City of Greenfield, Indiana, which is summarized on Exhibit A with a full text of the plan being available for inspection and review in the office of the Clerk-Treasurer of Greenfield, Indiana at 10 South State Street, Greenfield, Indiana, Monday through Friday from 8:00 a.m. to 4:00 p.m.

SECTION II

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
