## ORDINANCE NO. 2024/27

#### AN ORDINANCE AMENDING ORDINANCE NO. 2024/25

**WHEREAS,** the Common Council of the City of Greenfield, Indiana has heretofore approved and adopted Ordinance No. 2024/25 on August 14, 2024; and

**WHEREAS,** said ordinance authorized certain expenditures from the Local Income Tax Public Safety Fund Account #2240 in order to purchase a fire engine and to pay off the loan of a 2022 Ford ambulance; and

**WHEREAS,** after adoption of said ordinance, it was learned that the loan payoff for the 2022 Ford F550 PL Custom Ambulance was incorrect and that the additional sum of \$33.57 was needed to pay off the aforementioned loan balance; and

**WHEREAS,** the Common Council of the City of Greenfield, Indiana believes that the additional appropriation of the sum of \$33.57 from the Local Income Tax Public Safety Fund Account #2240 is in the best interest of the health, welfare, and safety of the citizens of Greenfield, Indiana and the prudent financial management of the Greenfield Fire Territory funds.
