Code §§36-8-3.5-10 and 5-3-1, the Greenfield Fire Territory Merit Commission (the "Commission") hereby provides notice that on July 8, 2025, at 9:00 a.m. in the council chambers, 10 South State Street, Greenfield, IN, 46140, the Commission will conduct a public hearing during its duly noticed public meeting to consider adoption of amendments to the merit rules for members of the Greenfield Fire Territory. The adoption of the amendments to the rules is in the furtherance of the Commission's stated purpose to establish the processes for selection, promotion, discipline, demotion, and/or dismissal of a merit firefighter and to provide review and oversight of those processes, and to conform to Indiana law.

At the hearing, any interested person of the unit or territory and any member of the Greenfield Fire Territory must be afforded an opportunity to present both oral and written evidence on any matter relating to the adoption of the amendments to the rules. The Commission shall give due consideration to this evidence in making the Commission's final decision concerning the adoption of the amendments. A copy of the proposed amendments to the rules is available for inspection in the City of Greenfield Clerk Treasurer's office located at Greenfield City Hall, 10 South State Street, Greenfield, IN 46140.
