Notice is hereby given that the City of Greenfield Redevelopment Commission (the "Redevelopment Commission"), as the governing body for the City of Greenfield Redevelopment Department, pursuant to Indiana Code 36-7-14, as amended (the "Act"), adopted a Declaratory Resolution on December 10, 2024 (the "Declaratory Resolution"), amending the Greenfield Consolidated North Economic Development Area (the "Original NED Area") (which also designated the entire Original NED Area as an allocation area pursuant to Section 39 of the Act (the "Original NED Allocation Area")), and by deleting certain parcels from the Original NED Allocation Area (the "2024 NED Parcels") and adding such 2024 NED Parcels to a newly created "2024 NED Allocation Area," as further described in Exhibit A of the Declaratory Resolution (the "2024 NED Allocation Area Amendments"); and

A general description of the 2024 NED Allocation Area Amendments is fully described in the Declaratory Resolution. No changes were made to the City of Greenfield Consolidated Economic Development Plan.
